NEW BUSINESS – Board of Trustees Awards of Excellence	Each year the Board of Trustees recognizes employees in several categories who have made significant contributions to the institution through their assigned duties and responsibilities, through efforts going beyond their regular assignments, through providing exceptional leadership in helping the College to fulfill its mission and achieve its vision, or who have made significant contributions to the community through their service. The recipients will be honored at the Employee Appreciation Reception.

NEW BUSINESS – Fees for Early Childhood Center	We annually review our fees for the full-day and hourly rates for the Early Childhood Education Center. Ms. Partch and Mr. Kimmel's recommendations, along with supporting background information and rationale, were provided for the Board. The recommendation was for a slight increase in the full-day and hourly rates for FY17.The full-day (5 days/week) rate would be increased by \$1.00 to \$41.00, the Full-day (1-4 days/week) rate would be increased by \$1.00 to \$43.00, and the hourly rate would be increased by \$0.20 to \$8.20/hour.

Dr. Borowicz presented the President's Report.

Highlights

- Kevin Fuss was invited to present at the March meeting of the DeKalb Area Retired Teachers Association. His presentation provided a history of the College as well as current highlights and challenges. The group expressed their appreciation for the information and expressed a desire to invite College representatives to future meetings.
- Miles Halpern, Art Faculty had an essay published in a catalog that will accompany an art exhibition at the Research House for Asian Art, in conjunction with the School of the Art Institute of Chicago. The exhibition is called Analog RAM: The Return of Active Memory. The show opens this Friday, and runs from April 8-29th.
- Michelle Erickson-Goettl and Miles Halpern collaborated between Ceramics and Life Drawing. The classes joined for the first time to do figure sculpting with plasticine clay.
- Kacy Abeln was the recipient of the 2016 Dennis-Ross Outstanding Speech & Debate Coach Award, given annually to one university or community college coach considered to be the most outstanding coach of the year. This is the second state or national coach of the year award won by a Kishwaukee College coach in the last 5 years (Chase Budziak, 2013).
- Dariana Mahaffey, Coordinator of Youth-WIOA, was elected to be the Vice Chair of the Networking for Families (NFF) organization. NFF is a group of social service providers who meet monthly to help improve the lives of DeKalb County's low-income citizens.
- OC Imageworks submitted the Kishwaukee College Collision Repair full-length video to the AVA Digital Awards competition. The video won a Platinum Award, the highest honor, for Video Production in the Education/College/ Trade Category. Only 14% of those that entered received this honor. The video was produced through a great partnership with OC Imageworks and was spearheaded by Laura Chiavini, Creative Communications Specialists in Marketing & Public Relations.
- Food Security Summit: Combating Hunger in DeKalb County. The nursing students are organizing a poverty simulation with the NIU nursing students, Northern Illinois food bank and Live Healthy DeKalb to be held on Wednesday, April 27th at the DeKalb County Outreach building.
- Kayte Hamel, Director of Marketing & Public Relations, was re-elected and appointed as the National Council for Marketing & Public Relations District 3 Director at the National Conference held in St. Louis, Missouri, March 13-15. District 3 consists of Illinois, Indiana, Michigan, Ohio and Wisconsin. This is Hamel's second two-year term.
