## Tax Season Reminders for <u>Veterans</u>

Are you preparing to file taxes? VA is here to help with some helpful reminders for Veterans and beneficiaries.

- VA benefits are tax free.
- There is no federal income tax on VA insurance proceeds.
- Veterans with a serviceconnected disability rating may benefit from local property tax exemptions.
- You may qualify for free assistance with filing from MilTax or IRS Free File.



History Corner Four Chaplains Day February 3, 1943

An extraordinary act of heroism occurred in the icy waters off Greenland after the U.S. Army transport ship Dorchester was hit by a German torpedo and began to sink rapidly. When it became apparent there were not enough life jackets, four U.S. Army chaplains on board removed theirs, handed them to frightened young soldiers, and chose to go down with the ship while praying.



✓ Important reminders regarding your Veteran Benefits:

-For Chapter 33 benefits you must have at least one course in-residence (in-person or hybrid) to qualify for the maximum Housing Allowance benefit. Asynchronous, Synchronous and Flex coursework count as online learning. Full-time enrollment (12 or more credits) also qualifies for full MHA.

-All remedial courses taken (less than 100 level) MUST be in-person. Online remedial courses are not covered by Federal Veteran Benefits. State benefits may cover online remedial coursework.

-A request for benefits form MUST be submitted to the Financial Aid office <u>each semester</u> you wish to utilize Veteran Benefits for your training.
