
## Spotlight a Vet

### Helpful tips about using VA Benefits

Q: How often do I need to submit a Request for **Certification?** 

A: If you wish to utilize your VA benefits, you must submit an Enrollment Certification Request EACH semester. Contact Wendy Goff for more info wqoff@kish.edu.

Q: How do I continue to receive a monthly room and board stipend in Spring 2022?

A: The COVID waiver for Resident credits is expiring in December so to be able to receive room and board at the highest level the student must be enrolled in at least ONE In-Person course in Spring 2022.

History Corner

## Coast Guard

August 4, 1790

The Coast Guard's official history began on 4 August 1790 when President George Washington signed the Tariff Act that authorized the construction of ten vessels, referred to as "cutters," to enforce federal tariff and trade laws and to prevent smuggling.

#### Where are we in the VA process?

Effective January 1 2021 the VA will now require schools to certify and verify student attendance twice throughout the semester. The first certification will be no later than the first week of the semester. The second will be within 30 days of the start of the semester. Kishwaukee College will certify initial enrollments at the end of the Summer Semester but before the end of the first week of classes. The second certification will be after the Add/Drop period.

>In addition, the VA will also require student to verify their attendance, for housing allowance purposes, each month they are in classes. Failure to certify could result in delays of housing payments so make sure you are certifying with the VA.

>Lastly, the COVID-19 housing waiver which allows schools to certify students for Residency status will expire at the end of the year on December 31, 2021. This means that any students planning to utilize Chapter 33 funds for Spring 2022 semester will need to take classes in person in order to qualify for the housing stipend.
